Minutes of Langcliffe Parish Council meeting held on the Zoom platform on Monday 2nd November 2020 at 7.30pm.

Councillors present – G. Cross (Chairman), H. Jarvis, B. Fiorato, J. Bagnall, J. Sugden, D. Staveley, A. Blackburn (Clerk). Public present – none.

81/20. Apologies for Absence – B. Croft, I. Johnson.

82/20. Code of conduct – localism Act 2011

83/20. Minutes of the Parish Council meeting held on the 5th October 2020 - Approved.

84/20. Matters Arising – Actions

Ref: 66/20 – The Clerk had not received permission from the current owners of the property on Middle Fold for the street sign installation, Council deferred the installation until the property is sold and permission is obtained from the new owner.

78/20 – No correspondence received from YDNP in response to the reply sent by the Clerk regarding tree root damage during installation of the car park bin store.

85/20. Public Participation. None present.

86/20. District/ County Councillor Report.

Cllr Staveley gave a short CDC report.

Waste collection service to continue as normal during the planned Covid 19 lockdown.

CDC were still seeking a solution to the brown bin collection issue due to the removal of the standard waste collection service at Howsons Lane/ Pike Lane area.

The Government will send out their preferred devolution model for consultation by the community within the next few months.

87/20. Car Park, Review.

Council discussed the recent work done within the car park including the new bin store and the removal of the garden area. Items discussed included resident's concerns.

The outcome of the recent work is the provision of six additional car parking spaces which has been utilised by residents and visitors to the village.

Cllr Sugden proposed that residents be consulted regarding planned works by the Council for the benefit of community awareness. Cllr Staveley suggested informing the community via face book, Cllr Jarvis volunteered to compile a Parish Council face book page and Council resolved to approve.

88/20. Play Area.

Equipment. - Cllrs Jarvis & Bagnall have installed the play area Covid 19 sign.

Cllr Jarvis informed Council that pricing for replacement play area equipment was approximately £10,000 having consulted a number of equipment manufacturers. Also assistance in funding the project was proving difficult, Cllr Staveley suggested company sponsorship could prove successful for this project, Cllr Jarvis to enquire.

Survey Report. - The Clerk highlighted faults found by Playsafety Ltd during the recent risk assessment, Council discussed the faults including worn swing bushes and tile gaps.

Action – Clerk to inspect bushes & tiles to determine repair/ maintenance.

89/20. British Legion – donation.

Council resolved to donate £30 to the RBL Poppy Appeal in addition to the purchase of the wreath. **Action** – Clerk to include within the finance schedule for December.

90/20. Planning Applications.

Council discussed and approved the above application.

Action – Clerk to submit the Council decision to CDC Planning.

Cllr Jarvis reported an overhanging tree obscuring a 30 mph road sign near the railway bridge. **Action** – Clerk to investigate and report to Highways.

The recent emergency flooding incident in Langcliffe village was discussed, the large amount of rainfall and fallen leaves blocking drains a suggested cause. Road drains had only recently been cleared, Highways had been made aware.
